

Prize Promotion Rules

1. Relationship to the General Promotion Terms and Conditions

These Prize Promotion Rules (the “Rules”) supplement and give effect to the Organiser’s General Promotion Terms and Conditions (the “General Terms”). In the event of any conflict between these Rules and the General Terms, the General Terms shall prevail unless otherwise expressly provided in these Rules. Capitalised terms have the meanings defined in these Rules or the General Terms.

2. Gameplay

2.1 Format and access

The promotion is a single-question guessing competition (the “Promotion”) accessible during the Participation Period (i) on-site at the Moss booth at OMR Festival 2026 in Hamburg by scanning the QR code displayed on the booth installation, and (ii) online via the dedicated promotion website. Participation is free and does not require the purchase of any product or service. Participants are asked to guess the answer to a accounting related question (the “Question”). The figure to be guessed is based on the average monthly volume of card transactions, invoices and reimbursements processed by a highly engaged Moss customer in Germany (March 2026), multiplied by 18 years – an approximation of the average lifespan of a German company. The physical receipts and invoices displayed in the booth installation at OMR Festival 2026 are a visual representation of scale only and do not correspond to any specific number of real transactions.

2.2 Entry

To submit an entry, a participant must:

- (a) submit a numerical guess (the “Guess”);
- (b) provide their first name, last name and a professional email address;

- (c) optionally provide their company name;
- (d) accept the General Terms and these Rules and acknowledge the privacy notice; and
- (e) confirm that they are at least 18 years of age.

By submitting these details in full and truthfully, the participant becomes a “Participant” and their entry an “Entry”.

2.3 One Entry per person

Each Participant is permitted to submit one (1) Entry only. Where multiple Entries are received from the same person (identified by email address or other reasonable means), only the first valid Entry will be considered, and any further Entries will be disregarded.

2.4 Confirmation

Upon successful submission, the Participant will receive a confirmation email recording their Guess. A printed receipt may also be issued at the Moss booth.

3. Prizes

3.1 Prize table

Category	Prize	Selection
Main Prize	One (1) Treatwell gift voucher to the value of EUR 250	Closest valid guess to the official answer (deterministic)
Promotional Offer	A one-time promotional code from Moss (where lawfully accepted; subject to separate redemption terms)	All Participants who validly enter and opt in to receive the offer

3.2 Treatwell voucher

The Treatwell voucher is subject to Treatwell’s own terms of use, is non-redeemable for cash, non-transferable, and can only be redeemed in markets where Treatwell operates. The Organiser accepts no liability for redemption restrictions imposed by Treatwell.

3.3 Promotional offer

The promotional offer is subject to separate redemption terms communicated together with the offer. The offer is personal to the Participant, non-transferable, and may not be combined with other offers unless expressly stated. The Organiser may withdraw or modify the offer at any time prior to redemption to the extent permitted by law.

3.4 Allocation

The Main Prize will be awarded to one (1) Participant only. There is no cash alternative and the prize is non-transferable. The Organiser reserves the right to substitute the prize for an item of equivalent or greater value where, due to circumstances beyond its reasonable control, the prize cannot be supplied.

4. Winner Selection

4.1 Determination of the winner

After the close of the Participation Period, the Organiser will identify the Entry with the Guess closest in absolute value to the Official Answer. The Participant who submitted that Entry will be the “Winner” of the Main Prize.

4.2 Tie-breaker

If two or more Entries share the same closest distance to the Official Answer, the Winner will be selected from among the tied Entries by random draw conducted by the Organiser. The procedure of the random draw is documented internally.

4.3 Notification

The Winner will be notified by email at the address provided in their Entry at the Winner Selection Date.

4.4 Follow-up communications

All Participants will additionally receive (i) a results email confirming the Official Answer and the outcome of their Entry, and (ii) optionally, a final summary email with aggregated, anonymised statistics about the promotion. Participants who opted in to receive the promotional offer will receive it by separate email.

5. Data Protection

The personal data submitted by Participants is processed by the Organiser in accordance with its privacy notice, available on the dedicated promotion website. Personal data is processed for the purposes of administering the Promotion, identifying and notifying the Winner, and — where the Participant has opted in — sending the promotional offer and follow-up marketing communications. Participants may withdraw their marketing consent at any time.

6. General Provisions

The Organiser reserves the right to amend, suspend or terminate the Promotion at any time where required for legal, regulatory or operational reasons, without liability to Participants beyond what is required by mandatory law.
